- Sisa & Bahan Buangan – Pembinaan *permanent waste disposal* (PDF) sebelum kebenaran beroperasi diberikan, keselamatan sinaran bagi penyimpanan sisa di *residual storage facility* (RSF)
- Isu komuniti *internal emitters* – Ketidakpastian (uncertainties) kesannya terhadap kesihatan [*To err on the cautious side*]
